

LIABILITY STATEMENT OF BLOCK PARTY TRAILER USE AND STREET CLOSURE PERMITS

The applicant for a block party and/or street closure permit (“Applicant” or “Permittee” when/if a permit is issued) will be responsible for these rules and the conduct of the Block Party event (“Block Party” or “Event”). Read and understand these rules and acknowledge your understanding by signing below:

Block Party Trailer Use

- a. The Permittee shall remove and properly dispose of all trash generated during the event. Recycling is encouraged.
- b. Alcohol must be served and consumed on private property. Alcohol is not permitted within the public right-of-way.
- c. By City Ordinance §8.16.010, no unusually loud or unusual noise is allowed after 8:00 P.M.
- d. The open or public consumption of marijuana is not allowed in/on the street(s), alley(s) sidewalk(s), bicycle path(s), trail(s), parking strip(s), or other public place(s) within the permitted area or any other place(s) or area open to the public and/or in or on an automobile(s) or other vehicle(s) located on public property or public right of way. If marijuana consumption occurs in public or outside a private residence, even if on private property, it is a violation. Any violation may be cause for revocation of this or any other City issued permit and/or may be cause for other legal action(s) against the violator(s).

Street Closure Permittance

- e. The street is to be closed ONLY for the hours listed in the permit; the street closure(s) MUST be made with the barricade equipment provided by the City.
- f. Barricade equipment must be in the same condition at the conclusion of the Event as it was prior to the event. The trailer and equipment are provided “as is”; if any defect is discovered, please bring that to the City’s attention.
- g. All emergency vehicles will be allowed immediate access through the street if needed during the event; fire hydrant(s) cannot be blocked. I understand that reservation for use of the trailer and equipment and receipt of required permits for its use does not excuse any failure to comply with orders of law enforcement personnel, firefighters or other emergency workers, and that it does not provide immunity from civil claims of third parties that are based upon damages occurring at, or in conjunction with, an Event that uses the neighborhood block party trailer and equipment.

As the Applicant for the Event and in order to use the Neighborhood Block Party equipment and trailer, I certify that I have read and understand all of the information contained within the contents, care, rules and regulations document associated with the Neighborhood Block Party trailer and equipment. I agree to comply with each of those requirements, conditions and procedures. Barring expected wear and tear on the trailer and its contents, I agree to immediately reimburse the City for any and all costs to repair any damage to items incurred as a result of use of the trailer and equipment.

I HAVE READ, UNDERSTAND AND FULLY AGREE TO THE TERMS, CONDITIONS AND REQUIREMENTS HEREOF AND I UNDERSTAND AND CONFIRM THAT BY SIGNING, I AGREE TO INDEMNIFY AND HOLD HARMLESS THE CITY OF GRAND JUNCTION AND ALL CITY OFFICERS, EMPLOYEES, AGENTS AND REPRESENTATIVES, FROM ANY CLAIMS (INCLUDING COSTS OF DEFENDING SUCH CLAIMS) OR DAMAGES THAT MAY ARISE FROM THE OCCURRENCE OF USE, OR TEMPORARY STORAGE RELATED TO THE PREPARATION OR RECOVERY OF USE OF THE NEIGHBORHOOD BLOCK PARTY TRAILER AND EQUIPMENT AND RELEASE THE CITY FROM ANY AND ALL LIABILITY, CLAIMS, DAMAGES OR ANY CAUSE OF ACTION FOR PERSONAL INJURY AND/OR PROPERTY DAMAGE OR LOSS ARISING OUT OF OR UNDER USE OF THE SAME.

BY SIGNING THE BLOCK PARTY TRAILER RESERVATION REQUEST FORM, YOU ARE FREELY, KNOWINGLY AND INTELLIGENTLY AND DESIRE TO BE BOUND BY THE FOREGOING TERMS.
